Chairman Rick Aldom, W7STS had no issues to report.

First Vice Chairman's Report:

First Vice Chairman Lee Ilse, KD7OED reported on the Williams Hamfest

- The contract with the City of Williams will be signed in the upcoming week.
- The train ride will be arranged again this year. Lee went over the circumstances requiring ARCA handling the train reservations this year. The estimated price of the tickets will be \$75.00 with the possibility of a discount based on the number of ticket sold.
- It was reported in the newsletter "SKP WAVE" that this was the last year for the Williams Hamfest and that the camp out and swapmeet held at the Fort Tuthill campground sponsored by others will be replacing it. Lee reported that there have been several votes by ARCA member clubs on this issue and that each time the vote was overwhelmingly in favor of remaining at Williams. Any decision to relocate or discontinue the Williams event will be decided on by ARCA delegates and member clubs. Lee is pursuing a printed retraction in the SKP WAVE. (See New Business)

Section Managers Report:

AZ Section Manager Tom Fagan, K7DF reported on the following:

- Tom Reported on PRB-1, AZ House Bill 2615. The bill made it through both the House and the Senate, but was stalled at the last moment and not allowed to proceed to a vote in the Senate.
- Tom reported on the possibility of ARCA getting a portion of the Arizona Ham Radio License Plate Fee. His Liaison in the DMV told him that the state is willing to consider this, but we will need at least four times the existing participation to fund the program without resulting in a financial loss for the state. He also spoke of the importance of ARCA granting scholarships, supporting emergency communications and participating in community outreach programs.

Frequency Coordinators Report:

Repeater Coordinator Chair Lance Halle, KW7LH was absent

- Lance reported by e-mail that he had supplied the latest list of repeaters in the state to the ARRL.
- Lance reported that ARCA is a Charter Member of the National Frequency Coordinators Council (NFCC)
- It was mentioned in the general discussion that some Arizona repeaters my be in conflict with the repeaters in neighboring states because a significant number of Arizona repeaters are grandfathered under the old "Channeling Plan"
